As part of the HK Member Group's commitment to bring to you relevant and up-to-date views on topics of wide interest, we are hosting a CPE luncheon where you will have the chance to listen to Stephen Cheung, a renowned Finance Professor at the City University of Hong Kong who will speak on Corporate Governance and Hong Kong's Scorecard. Professor Cheung has conducted a study on over 174 Hong Kong HSI constituent stocks and he will share his team's findings on the subject.

Professor Stephen Yan-Leung Cheung is a Professor (Chair) of Finance in the Department of Economics and Finance in the Faculty of Business at City University of Hong Kong. Professor Cheung has published 62 articles in international refereed journals including the Journal of Financial Economics, Journal of Empirical Finance, Journal of Financial Markets, Journal of Futures Markets, and Journal of Business Finance and Accounting. He was ranked the sixth most productive finance researcher in the Asia-Pacific region, including researchers from universities in Australia and New Zealand, during the period 1990-1999, and was ranked the fourteenth most productive author in Asia-Pacific universities by weighted number of articles in 18 accounting journals during the period 1991-2002. Professor Cheung was the founding Head of Research at the Hong Kong Securities and Futures Commission in 1999.
