### Part II

## 1. Course Synopsis

This course aims to analyse the growing integration of Hong Kong with Mainland China socially, economically, culturally and politically. Transforming from a trading port under British rule into a global financial, business and transportation hub in the 21st century, Hong Kong has leveraged on its many linkages with the changing global political economy since World War II and with the Mainland since 1978, particularly after the resumption of Chinese sovereignty in 1997. Multidisciplinary perspectives from history, sociology, political science and urban studies will be employed to understand the changing political, cultural and socio-economic interactions between Hong Kong, the Pearl River Delta (PRD) and other parts of the Mainland on the path toward greater integration. Part I examines the historical evolution of Hong Kong since the early colonial era to its establishment as a Special Administrative Region (SAR) of the People's Republic of China (PRC). Special focus will be placed on how both global forces, the responses from the Hong Kong community, as well as central policies have shaped Hong Kong's transformation into a global city in China. Part II first introduces different disciplinary perspectives on the study of political, socio-cultural and economic integration, and then examines the growing interactions between Hong Kong and the Mainland during the path toward integration in these three domains. Part III focuses on the key challenges and opportunities facing Hong Kong, the Greater Bay Area (GBA), and the Mainland, especially in light of the recent policies initiatives in GBA planning amid the global transformation brought by COVID-19.

- CILO<sub>3</sub> understand and evaluate the key issues, challenges and opportunities facing Hong Kong, the Greater Bay Area, and the Mainland on the path toward integration;
- CILO<sub>4</sub> develop analytical, research and communication skills in social science research and apply them in their presentation, reflective journal and essay.
