Local Students Eligible for Government-subsidised Tuition Fees (Effective from the 2027/28 Entry)
符合政府資助學費本地生（由 2027/28 年度起生效）

According to [the government](#), the criteria for **LOCAL STUDENTS eligible for government-subsidised tuition fees** for the purpose of admission to post-secondary programmes from the 2027/28 entry are given as follows:

LS1	Hong Kong Permanent Identity Card (Sample) 香港永久性居民身份證 (樣本)
LS2	Documents issued by the Immigration Department of the HKSAR showing right to land / right of abode in Hong Kong (Sample) 由香港特區入境事務處簽發享有香港特區的入境權 / 居留權之證明文件 (樣本)
LS3	Hong Kong Identity Card + One-way Permit for entry to Hong Kong (Sample) 香港居民身份證 + 中華人民共和國前往港澳通行證 (單程證) (樣本)
LS5 (Cat-I)	Hong Kong Identity Card + Dependant visa / entry permit (for students who were below 18 years old) ^{Note 1} (Sample) + Fulfilment of residency requirement ^{Note 2} 香港居民身份證 + 受養人簽證 / 進入許可證 (未年滿 18 歲的學生) ^{註 1} (樣本) + 符合其中一項居港規定 ^{註 2} ^{Note 1} Holders who were below 18 years old when first issued with such visa / entry permit by the Immigration Department of the HKSAR. ^{註 1} 持有人首次獲香港特區入境事務處簽發受養人簽證 / 進入許可證時必須未滿 18 歲。 ^{Note 2} Resided in Hong Kong for two years immediately preceding the first day of their respective programmes: (a) The applicants are enrolled as a full-time student in a school offering a formal curriculum in Hong Kong recognised by the Education Bureau (EDB), no later than 15 September of each academic year, for the two-year period* ending on 31 May in the year in which applicants' respective programme begins; OR (b) For applicants who do not meet (a) above: a Statement of Travel Records of the applicants which can be obtained at a fee from the Immigration Department of the HKSAR covering the two-year period to demonstrate that the applicant is not absent from Hong Kong for a maximum of 90 days in each year of the two-year period*. ^{註 2} 須符合緊接所修讀課程開課首天前的兩年期的居港規定，並符合以下其中一項： (a) 申請人在計至所修讀課程開課當年的 5 月 31 日為止的兩年期*內以全日制學生身份在教育局認可於本港開辦正規課程的學校就讀，並於指定日期前完成入學；或 (b) 不符合上文 (a) 項的申請人，須提交向香港特區入境事務處付費申領涵蓋該段兩年期的出入境紀錄證明，以顯示申請人在該段兩年期*內，每年不多於 90 天不在香港。 [*]For the 2027/28 entry, a ONE-year transitional residency requirement will be implemented.
