

Senior Education Officer (Holding a substantive rank of Senior Lecturer II/ Lecturer I) (Ref: SEO(SLII/LI)/ELE/0421) Department of English Language Education

The appointee will report to the Project Leader and his delegate(s). He/She will be responsible for overseeing the development of innovative curricula, evaluation methods and tools, and teaching and learning resources in the project of "English Language Education for Students with Learning Diversity in Primary Schools" (hereafter named the project) in the University and local schools, with the engagement of EdUHK students; designing and implementing research and evaluating as well as coordinating the dissemination of the project; teaching courses on English Language Education for undergraduate programmes and/or above; establishing partnerships with schools and other agencies; contributing to departmental and Faculty services and undertaking any other duties as assigned by the Project Leader or his delegate(s). Tertiary management or teacher education experiences could be an asset. The successful applicant will be appointed for a period of 24 months.

Applicants should have a Master's Degree, preferably in areas of Education, English language or related subjects, and/or with a Postgraduate Diploma in Education (PGDE) or qualification of Qualified Teacher Status (QTS) recognized by the Education Bureau of Hong Kong or other qualification of equivalence. He/She should have at least 8 years of relevant post-qualification in teaching/curriculum leadership in Hong Kong education or preferably a Doctoral Degree plus a minimum of 3 years' relevant post-qualification. Applicants should preferably possess relevant professional school support or experiences or school-based curriculum development on the area of English Language education. Applicants with less experience may be considered for the rank of Lecturer I.

Salary will be commensurate with qualifications and experience.

Initial appointment will be made on a fixed-term contract. Fringe benefits include contract-end gratuity, leave, medical and dental benefits.
