The Department is now seeking qualified and highly dedicated persons to assist in teaching and support for teaching professional development courses for students with special educational needs for project named “Provision of Services for the Basic, Advanced and/or Thematic Courses for Teacher Professional Development on Catering for Students with Special Educational Needs for the 2021/2022, 2022/2023 and 2023/2024 School Years”. The appointee(s) is expected to commence the employment in January 2022.

The appointee(s) will participate in online and/or in-person activities related to teaching; research projects for knowledge transfer; curriculum and programme development; development of teaching and learning materials; practicum supervision and programme and course management. Field work may also be required.

For the post of Senior Lecturer II, applicants should have a Master’s degree in a relevant subject discipline plus a minimum of 8 years’ relevant post-qualification teaching experience in teaching of students with special educational needs; or preferably a Doctoral degree plus a minimum of 3 years’ relevant post-qualification teaching experience in the subject applied for.

For the post of Lecturer I, applicants should have a Master’s degree in a relevant subject discipline plus a minimum of 4 years’ relevant post-qualification teaching experience in teaching of students with special educational needs. Applicants who have less relevant post-qualification teaching experience in the subject applied for will be considered for the post of Lecturer II.

Applicants should preferably possess a relevant professional teaching certificate, e.g. PGDE or qualification of Qualified Teacher Status (QTS) recognized by the Education Bureau of Hong Kong or other qualification of equivalence. Demonstrate ability in the use of IT in SEN support and provide proven evidence of quality teaching and/or successful record of relevant professional/clinical experience, at primary/ secondary and or tertiary level. Significant contributions to in-school curriculum development, teacher development and/or clinical support would be preferable. Also, frontline experience in e-learning and e-teaching will be an advantage.
