The Department of Social Sciences and Policy Studies invites applications for full-time Lecturer I/II positions with a specialisation in one or more of the following areas: (i) entrepreneurship and social entrepreneurship; (ii) social organisation and leadership; (iii) Financial planning and human resource management; (iv) corporate social responsibility.

The appointee will participate in activities related to teaching, project supervision, curriculum and programme development, together with programme and course management at the undergraduate and postgraduate levels. He/she is expected to be an active scholar committed to pedagogical innovation, the development of teaching techniques to assist students with learning difficulties, and to actively contribute to the whole-person development of students through active mentorship. Moreover, he/she will support the department in fostering an environment that encourages students' practical application in the fields of entrepreneurship and social entrepreneurship.

Applicants should provide evidence of past and current teaching accomplishments and a statement of teaching interests.

Applicants for the post of Lecturer I should have a Master's degree, preferably a Doctoral Degree, in a relevant discipline plus a minimum of 4 years' relevant post-qualification teaching experience in the subject applied for. Applicants with less teaching experience may be considered for the post of Lecturer II. Applicants should preferably possess a relevant professional teaching certificate, e.g. PGDE or qualification of Qualified Teacher Status (QTS) recognized by the Education Bureau of Hong Kong or other qualification of equivalence, and provide proven evidence of quality teaching and/or successful record of relevant professional experience, at primary/secondary and or tertiary level. Strong background and interest in business and social entrepreneurship, preferably with industry experience in these fields, are highly desirable.
