The Department of Science and Environmental Studies invites applications for the positions of Senior Lecturer II, Lecturer I, or Lecturer II. The successful appointee will primarily be responsible for teaching Chemistry and Environmental science-related courses, along with method courses in Science and education at both undergraduate and postgraduate levels. Key responsibilities include planning, developing, implementing, delivering, and evaluating course content.

The appointee will also assist in supervising teaching practicums and student projects, oversee program activities, enhance the student learning experience, supervise fieldwork, and provide academic guidance to students in the capacity of academic advisor. Additionally, the successful candidate will contribute to the development of teaching modules and self-directed learning materials, as well as perform other duties as assigned by the Head of Department.

Qualifications:

- **For Senior Lecturer II:**
 - A Master's degree in Chemistry, Environmental Science, Science Education, or a related discipline with a minimum of 8 years of relevant post-qualification teaching or professional experience.
 - Alternatively, candidates with a Doctoral degree should have at least 3 years of relevant post-qualification teaching or professional experience, along with evidence of high-quality teaching at the primary, secondary, or tertiary levels.
- **For Lecturer I:**
 - A Master's degree in Chemistry, Environmental Science, Science Education, or a related discipline with a minimum of 4 years of relevant post-qualification teaching experience.
 - Candidates should provide evidence of quality teaching and/or a proven record of successful, relevant professional experience at the primary, secondary, or tertiary level.
- **For Lecturer II:**
 - A Master's degree in Chemistry, Environmental Science, Science Education, or a related discipline. Applicants with less relevant post-qualification teaching experience may be considered for this position.

Applicants with relevant professional teaching certificates, such as the Qualified Teacher Status recognized by the Education Bureau of Hong Kong, or other equivalent qualifications, are preferred. The successful candidate is expected to be highly versatile in their teaching abilities and to demonstrate excellent interpersonal skills. Applicants with science, environment, or science education expertise are preferred.
