We are seeking two highly motivated and experienced Research Assistants (RA I) to support a government-funded research project that investigates drug-use behaviors among ethnic minority communities in Hong Kong.

#### **Major Duties**

- Assist in the design, planning, and execution of empirical research activities, including but not limited to literature reviews, archival research, data collection using both qualitative and quantitative methodologies, data analysis, and interpretation.
- Conduct comprehensive literature reviews to support the development of the research framework and methodology.
- Manage and maintain research databases, ensuring accuracy, integrity, and confidentiality of data.
- Coordinate and conduct fieldwork, including interviews and surveys with research participants.
- Prepare research reports, summaries, and presentations for dissemination to the funding agency, stakeholders, and the academic community.
- Collaborate closely with faculty members, researchers, team members, and external stakeholders to ensure smooth project implementation.
- Assist with administrative tasks, including processing reimbursements, and organizing events and activities to promote public awareness and engagement with the research findings.
- Perform any other duties as assigned.

### **Qualifications and Requirements**

- A recognized degree in related disciplines such as public policy, public administration, communications, sociology.
- Candidates with a postgraduate degree or research postgraduate degree are highly preferred
- Experience in conducting empirical research and statistical analyses.
- Proven experience working with ethnic minority communities in Hong Kong is essential.
- Experience in anti-drug initiatives or community-based interventions in Hong Kong will be an advantage.

#### **Appointment Terms**

Two positions are available. The appointments will be until 14 September 2026.

Salary will be commensurate with qualifications and experience.

Initial appointment will be made on a fixed-term contract. Fringe benefits include contract-end gratuity, leave, medical and dental benefits.
