#### **Part II**

The University's Graduate Attributes and seven Generic Intended Learning Outcomes (GILOs) represent the attributes of ideal EdUHK graduates and their expected qualities respectively. ## 1. Course Synopsis

Ecotourism has been regarded as an environmentally friendly mode of tourism since the past decades and it has been regarded as an important niche to help in achieving sustainability in the tourism industry. Countries endowed with rich natural resources actively develop and promote ecotourism. This course introduces the concepts and the principles of ecotourism. Various ecotourism practices of local and overseas countries will be examined to equip students with the fundamental knowledge of the tourism industry. This course is useful to students with different background in arts, education, social sciences, and science disciplines.
