1. Course Synopsis

This is an introductory course about the processes and spatial patterns of human use of resources and the diversified cultures in a globalizing world. The major topics to be covered are processed that determine the location and distribution of human socio-economic organisations, such as agriculture and food supply. Emphasis will be placed on the processes that govern the development of human organisation and their impacts on the environment.

CILO₁: effectively use a variety of data to investigate both the temporal and spatial changes of major socio-economic and political activities

CILO₂: characterise and explain the interconnections amongst places, spaces, peoples and events

CILO₄: explain how globalisation gives rise to the complexity of the human-environmental relationship.
