Part II

The University's Graduate Attributes and seven Generic Intended Learning Outcomes (GILOs) represent the attributes of ideal EdUHK graduates and their expected qualities respectively. Learning outcomes work coherently at the University (GILOs), programme (Programme Intended Learning Outcomes) and course (Course Intended Learning Outcomes) levels to achieve the goal of nurturing students with important graduate attributes.

In gist, the Graduate Attributes for Sub-degree, Undergraduate, Taught Postgraduate, Professional Doctorate and Research Postgraduate students consist of the following three domains (i.e. in short "PEER & I"):

- Professional Excellence;
- Ethical Responsibility; &
- Innovation.

The descriptors under these three domains are different for the three groups of students in order to reflect the respective level of Graduate Attributes.

The seven GILOs are:

- 1. Problem Solving Skills
- 2. Critical Thinking Skills
- 3. Creative Thinking Skills
- 4a. Oral Communication Skills
- 4b. Written Communication Skills
- 5. Social Interaction Skills
- 6. Ethical Decision Making
- 7. Global Perspectives

1. Course Synopsis

This course aims to analyze the transformation of Hong Kong from a trading port under British rule into a global financial, business and transportation hub in the 21st century and examine how Hong Kong can position itself to seize the opportunities and cope with the challenges as part of the Greater Bay Area (GBA). Multidisciplinary perspectives from political science, sociology and urban studies will be employed to understand the changing political and socio-economic dynamics of the different communities at the local, regional and national levels. Special focus will be placed on the political, social and economic forces that have shaped the development of the entire south China region and the multi-faceted interactions between Hong Kong and other cities in the Pearl River Delta, which is now designated as the GBA, since China embarked on reform and open door policy in late 1978. This course is organized into three parts. Part I offers an historical and conceptual introduction to the study of the south China region. This begins with an overview of the historical evolution of Hong Kong from the colonial era to its establishment as a Special Administrative Region of the People's Republic of China (PRC), the changing social, economic and political links between Hong Kong and Guangdong province, and the developmental experience of this region since the late 1970s. Theoretical approaches in the study of globalization and regional development, such as global cities, global cityregions and regional governance, and their relevance for studying south China would also be critically examined. Part II focuses on several key issues in regional development and cooperation in the GBA, including intergovernmental relations, economic and technological development, demographic flows and boundary management, transportation and infrastructural development, as well as environmental protection and management. Part III explores the challenges and opportunities facing Hong Kong, other key cities in the GBA such as Shenzhen and Guangzhou, and other emerging regions in the Mainland, as well as their prospect in light of China's rise in the 21st century.

2. Course Intended Learning Outcomes (CILOs)

Upon completion of this course, students will be able to:

- CILO₁ Understand the competing theoretical perspectives in the social sciences that can be employed to analyze the transformation of contemporary Hong Kong community and other key cities such as Guangzhou and Shenzhen in the Greater Bay Area (GBA);
- CILO₂ Critically examine the changing relations between Hong Kong and other cities in the GBA, the other regions of Mainland China and the world;
- CILO₃ Understand the multi-faceted challenges facing Hong Kong and other GBA cities as the region strives to become an innovation and technology hub and a global city cluster;
- CILO₄ Explore the coping strategies that Hong Kong can consider and the challenges it faces in its positioning as China's international financial, transportation and trade centre;
- CILO₅ Develop analytical, research and communication skills in social science research.
